#### Renewal Checklist 🗹

Please make sure you have the following items in order to renew your business in June:

**Obtain new bond.** 2005 legislation requires all business with bonds to obtain the new bond form with a revision date of 4/2005. ATV/Motorcyle/Small Trailer Dealers and Crushers also must have a new bond amount of \$10,000. Body Shops must have a new bond amount of \$20,000. Please see your renewal packet for more information.

New/Used Motor Vehicle Dealerships must attend a three-hour refresher course. The refresher course can be taken anytime after April 1<sup>st</sup>. You can take the refresher course online at <a href="www.mved.utah.gov">www.mved.utah.gov</a> and click on Dealer Training or online through Wayne Jones at IADA. Live classes are also being offered by Sonja Jorgensen at (801) 347-5405; or Wayne Jones at IADA (801) 566-3802; or Dave Hale at Real Value Insurance at (801) 298-3811. \*This class is not required for New/Used ATV/Motorcycle/Small Trailer Dealers.

If you have Dealer, Dismantler, Manufacturer or Transporter plates, you MUST have a copy of your current insurance declaration page. The declaration page should list your business name, your insurance company information, policy number and expiration date. Make sure your policy is not expired. We will NOT accept your paperwork without valid proof of insurance.

Please review your renewal packet and verify which dealer plates and salespeople you need to renew. If you renew online you do not need to obtain signatures from your currently licensed salespeople.

If deleting an owner from your business, you must have a resignation letter from that person.

If adding owners, they must have their 8 hour training certificate (for new or used car dealerships), photo, fingerprint card, and fingerprint waiver (TC-465) along with \$15.00 for their background check.

If adding a franchise to your business, you must have a letter from the company authorizing the franchise of their product.

If a salesperson no longer works for your dealership, please send in their license to MVED with their suspended date.

If you have a new salesperson that starts in June, you will need to pay for a new license that will expire on 6/30/05. Then they will need to renew by 6/30/05 to obtain a

license valid until 6/30/06.

Renewals can be done online to save your business valuable time and money!

Just renew online, send in the required items that are listed on the renewal summary and we will mail you all of your licenses. It is quick and easy and you can pay by check or credit card.

#### **Temporary Permits**

The fee for temporary permits books is changing on **7/1/2005**. The permits will be **\$169.00** per pad of 25 permits. If the incorrect fee is submitted or postmarked on or after **7/1/2005** we will return your order form for the correct fee. You can order permits online and pay by credit card and we will simply mail them to you. We also have the ability to ship permits out via Federal Express. Call MVED at 801-297-2600 for more details or to obtain a password to place your online order.

Remember that temporary permits must be visible from the rear of the vehicle. They must be in a place where the information on the permit and the expiration date may be easily seen. The expiration must be legible from a distance of 30 feet. Temporary permits must not be placed in rear windows with less than seventy percent light transparency. Seventy percent light transparency is comparable to a front windshield. The new temporary permits, issued on or after 4/2004, also require the expiration month and day to be circled. Please also mark, when applicable, the type of vehicle on the lower section of the first stub.

#### **Title Applications**

We have been getting quite a few sales reported to the DMV with an incorrect Dealer number. If you have a Transporter license and a Dealership license be sure to list your **Dealer number** on the title application in the dealer report of sale section. Also be sure to supply all of your retail customers with the title application TC-656D even if you sell the car as is and do not permit it.
