#### **NEW LEGISLATION AND OTHER ISSUES FOR 2006**

Senate Bill 226 modified the Motor Vehicle Code authorizing a dealer to issue a temporary permit to a purchaser for a period not to exceed 45 days rather than the current 30 days. The legislation also allows a dealer to apply for a title and license plates for a vehicle sold to a purchaser within 45, rather than 30 days. This law goes into effect on July 1, 2006 at which point the new 45 day temporary permits will be available for sale. House Bill 283 repealed dealer notice requirements to a lien holder if the dealer takes a trade-in from a retail customer as part of a sale or lease and there is an outstanding loan balance owing on the trade in.

Senate Bill 180 provides that a dealer leasing a vehicle may not issue a temporary permit or release possession of a motor vehicle unless a dealer makes required disclosures regarding financing arrangements in a contract regarding the lease agreement. The law also provides penalties if a dealer does not properly execute the required disclosures or if the dealer is unable to secure financing arrangements as set forth in the disclosures.

Legislation passed last year is requiring that all motor vehicle dealers have a \$75,000 bond as of July 1, 2006. The Division will not renew a motor vehicle dealer's license unless we have a new bond or bond rider. Copies of the bond or bond rider are not acceptable. If you have questions on the new bond requirement, contact your bonding company or MVED at 801-297-2600. \*Motorcycle, small trailer or off highway vehicle bond amounts are not changing.

MVED is continuing to find motor vehicle dealers selling away from the dealer's licensed location without an off-site permit. These permits are required when displaying vehicles for sale away from the dealership. MVED investigators routinely inspect car shows, malls and special events to insure that dealers have the required licenses to display and sell vehicles away from the dealership's licensed location. To apply for an off site sale please submit a TC-758, photo of the sign showing the dealer information to be used at the sale, and payment for \$26.00.

Dealers need to continue to insure that salespersons are licensed *immediately* when hired. The law does not provide a grace period for new employees. Fines can be stiff for violations, starting out at \$250.00 for the first offense and \$5,000.00 for a third offense during a 12-month period.

Dealers have called MVED about questions on why salespersons have had their license denied or suspended by the division. Utah law gives MVED a statutory responsibility to deny or suspend a salesperson licenses for offenses such as:

- Nonpayment of required fees;
- Making a false statement in an application;
- Violation of any state or federal law regarding motor vehicles;
- Violation of any state or federal law involving controlled substances;
- A violation of any state or federal law involving fraud:
- A violation of any state or federal law involving a registerable sex offense;
- Charges filed with a local prosecutor or U.S. Attorney for a violation of any state or federal law involving motor vehicles;

### MVED INVESTIGATIONS OF UNLICENSED DEALERS

MVED has assigned two investigators to work full time during the summer doing unlicensed dealer investigations. In the last six months, MVED investigators have filed approx. 120 criminal counts against unlicensed car dealers with many more cases set to screen with local prosecutors.

MVED investigators have also targeted improperly registered vehicles for sale by unlicensed car dealers on busy streets. Investigators have impounded over thirty vehicles during the last few months. The division's special operations section has also been working many weekends, including Sundays, in order to be more effective in investigating this type of crime.

### FRANCHISE REQUIRED TO SELL *NEW* VEHICLES, TRAILERS, OFF-HIGHWAY OR MOTORCYCLES

Utah Tax Code Annotated 41-3-210 (g) requires a franchise to be filed with MVED in order to sell new vehicles which includes trailers, off-highway vehicles or motorcycles. Selling without a franchise is a class B misdemeanor and a Level III violation. A Level III violation ranges from \$250.00 for the first offense to \$5000.00 for the third offense, in a 12 month period. 2006-2007 Renewal packets will be mailed out around the 2<sup>nd</sup> week of May. Please remember that if you are a new or used motor vehicle dealer, someone with the dealership must take the 3 hour refresher course in order to renew. Remember that you can save valuable time and money by renewing online! Renew online at <a href="https://www.mved.utah.gov">www.mved.utah.gov</a> Your log on and password will be on a blue piece of paper in your renewal packet.

Did you know that if you renew online you do not need salespeople to sign the renewal packet? This could save a large dealership several hours worth of work!

Did you know that you can pay online with a credit card? We accept VISA, Mastercard, Discover and American Express when renewing online.

Once you renew online you just need to send in the required documents listed on your confirmation page. Please remember that if you are a new or used motor vehicle dealer you also must submit an original new bond or bond rider changing your bond amount to be \$75,000. We will then process your renewal and mail back your licenses and decals. *It is quick and easy!*
