#### MVED MVP—Motor Vehicle Portal

Under the MVP website you can renew your business license, if you are a dealer you can purchase permits, clear temporary permits and do your monthly reports of sale, view your plate statuses, request a temporary offsite license, and request a salesperson transfer. When you set up an MVP log in you will get electronic renewal reminders each year. Go to mvp.tax.utah.gov to log in.

#### Adding MVP Access

If you are just setting up your MVP access for the first time a business owner must start the MVP login process. If the owner of your business chooses to allow someone to log in on their behalf of their business, then a PIN number will need to be provided to that individual. The PIN number is sent to the owner via email at the time they create their account. If there are multiple owners of the business then **ALL** the owners must set up a login to provide 3rd party person access to the account. We want ALL the owners to be aware of who has access to their MVP account so they can manage the logon rights. **An employee should NOT be logging in using the owner's login or setting up an account using the owner's personal info. If we find an account set up by an employee using owner information that account will be ceased. The owner will get an email similar to this when their account is set up:**

#### Transferring a salesperson license

One of the newest features on MVP is the ability to transfer a salesperson to your account. Once you log into your account click on the Request a Salesperson Transfer to Your Account Hyperlink

Please NOTE— submitting a completely filled out TC-303 application is still required when transferring a salesperson online. The TC-303 must be signed by the salesperson and the owner of the dealership or someone on file with MVED that has authorization to sign applications. You will add the TC-303 as an attachment online. The salesperson must have valid fingerprints on file with MVED to be eligible to use the online transfer process. The salesperson license will be mailed to your dealership once the transaction is processed.

### Advertising Violation

It has come to our attention that some dealers have been using the "wholesale pricing" in advertisements online. The word "wholesale" cannot be used in advertising. Please review R877-23V-7. Misleading Advertising Pursuant to Utah Code Ann. Section 41-3-210.

A violation of 41-3-210 is a class B misdemeanor. An advertisement violation is a level III violation and is in addition to the criminal penalties. Level III violations are as follows: \$250 for the first of-fense, \$1,000 for the second offense, and \$5,000 for the third and subsequent offenses in any 12

# 2023 Motor Vehicle Legislative Law Changes

#### HB194 Motor Vehicle Dealer Requirements (Effective July 1st, 2023)

This bill prohibits a motor vehicle dealer from requiring a purchaser to pay, as a condition of the sale, a fee or charge in addition to the negotiated purchase, other than: certain fees required by state or federal law, a dealer documentary service fee, and certain increases in price imposed by a manufacturer for semi-tractors with a gross vehicle weight rating over 14,000 pounds; specifies the civil penalties for a violation; requires a motor vehicle dealer to provide and execute a transaction disclosure form; requires the State Tax Commission to create the transaction disclosure form.

#### SB172 Vehicle Sales Amendments (Effective May 3rd, 2023)

The bill allows a licensed vehicle dealer to sell a vehicle to a buyer without the buyer being required to appear in person to one of the dealer's places of business; enter into a purchase contract, collect an electronic signature, and collect payment electronically; deliver a purchased vehicle to a buyer's home, place of business, or another location under certain circumstances.

# 2023 Motor Vehicle Legislative Law Changes (continued)

#### HB340 Trailer Registration Requirements (Effective January 1st, 2024)

This bill amends a provision related to trailers that are exempt from vehicle registration requirements to include a single-axle trailer unless the single-axle trailer is: a commercial vehicle; a trailer designed, used, or maintained for hire; or a travel trailer, camping trailer, or fifth wheel trailer with an unladen weight more than 750 pounds.

#### SB216 Vehicle Value Protection Agreements (Effective May 3rd, 2023)

This bill defines terms; allows a person to enter into a vehicle value protection agreement under certain circumstances; details requirements for cancellation of a vehicle value protection agreement; requires the provider of a benefit under a vehicle value protection agreement to: obtain contract liability insurance for the vehicle value protection agreement, provide other security for payment under the vehicle value protection agreement, or maintain a certain net worth; authorizes the Division of Consumer Protection (division) to enforce vehicle value protection agreement requirements; requires the insurer under a contract liability insurance policy for a vehicle value protection agreement and a provider of a vehicle value protection agreement to provide certain information to the division; provides fines and civil penalties for a violation of vehicle value protection agreement requirements; requires fines and civil penalties received by the division for a violation to be placed in the Consumer Protection Education and Training Fund.

#### SB85 License Plate Requirement Amendments (Effective May 3rd, 2023)

This bill allows a historical support special group license plate to be manufactured with a partially reflective plate face; and prohibits an individual from obscuring a license plate with a tinted or translucent license plate cover.

#### HB55 Off-Highway Vehicle Registration Requirements (Effective February 16th, 2023)

This bill exempts a snowmobile from the requirement to obtain and display a license plate for an off-highway vehicle; allow the Motor Vehicle Division to charge a fee for the issuance of a new or replacement license plate; and amends requirements related to off-highway safety courses.

#### HB200 Motor Vehicle Registration Revisions (Effective May 3rd, 2023)

This bill amends provisions related to registration of an off-highway vehicle to allow the transport of an off-highway vehicle that is not registered.

#### HB458 Clean Fuel Vehicle Decal Amendments (Effective May 3rd, 2023)

This bill provides that a clean fuel vehicle decal permit holder is not required to place the clean fuel vehicle decal on the vehicle.

# 2023 Motor Vehicle Legislative Law Changes (continued)

#### SB13 Motor Vehicle Registration Amendments (Effective July 1st, 2023)

This bill clarifies when the State Tax Commission may impose a registration reinstatement fee; creates the License Plate Restricted Account (restricted account); repeals the honorary consulate special group license plate; and provides that appropriations from the restricted account are nonlapsing.

#### SB92 Special License Plate Designation (Effective November 1st, 2023)

This bill creates the Great Salt Lake Preservation support special group license plate; and directs revenue generated by the support special group license plates to be deposited into the Sovereign Lands Management Account to enhance preservation of the Great Salt Lake watershed and ecosystem.

#### HB26 License Plate Amendments (Effective January 1st, 2024)

This bill defines terms; amends provisions regarding standard license plates; creates the sponsored special group license plate program and changes the process to establish a new special group license plate; provides for continuation of special group license plates that were created by a legislative act; establishes eligibility criteria for different categories of sponsored special group license plates; allows a county to exempt a motor vehicle from an emissions inspection under certain circumstances; creates a restricted account to administer existing fees related to license plates and vehicle registration; and repeals certain restricted accounts and other provisions related to license plates issuance and administration.

#### SB264 Modified Car Emissions Requirements (Effective May 3rd, 2023)

This bill defines the term, "restored modified vehicle"; at the request of the owner, allows the Motor Vehicle Division to notate the registration certificate of a restored-modified vehicle indicating that the vehicle is a restored-modified vehicle; requires an emissions inspection as a prerequisite to registration of a restored-modified vehicle; and prohibits a county emissions program from refusing to perform an emissions test based solely on the status of a vehicle as a restored-modified vehicle.

# HB49 Motor Vehicle Safety Inspection Advisory Council Amendments (Effective May 3rd, 2023)

This bill repeals the Motor Vehicle Safety Inspection Advisory Council.

## SB90 Automobile Franchise Amendments (Effective May 3rd, 2023)

This bill requires an automobile franchisor to: provide a franchisee with certain written disclosures that may be provided to a potential buyer of the new motor vehicle; and provide reasonable compensation to a franchisee assisting a customer whose vehicle was subjected to an over the air or remote change, repair, or update; and amends requirements for changes to a franchisee's retail labor rate and retail parts markup.
